Sub: Clarification of Revised Incentives for ASHA

Sir,

With reference to the subject cited above, it is observed that there are some confusion regarding the revised incentives for ASHA under JSY Scheme and Female Sterilization. So the following clarification is given.

JSY Incentive:

Order of delivery	Incentive to ASHA from JSY
After 1 st Delivery	Rs. 600.00
After 2 nd Delivery	Rs. 600.00
After 3 rd Delivery	Rs. 400.00
After 4 th Delivery	Rs. 200.00
After 5 th Delivery and above	Nil

Incentive to ASHA for female sterilization:

From Compensation Package : Rs. 150.00

Incentive (to be drawn from JSY fund): Rs. 350.00

Total: Rs. 500.00 per case

Upto March 2011, the motivation fee for ASHA for Female Sterilization will be \square 500.00 per case irrespective of no. of children of the acceptor. These revised incentives will not be applicable to other motivators for LS except ASHA i.e, ASHA only will get \square 500.00 and others will get \square 150.00 only.
