The above referred news published in the *The Janasadharan* has come to our notice and Health & Family welfare Department, Govt. of Assam vehemently denies the allegation that the Health Department has not receiving fund from Central Governments for combating Japanese Encephalitis in the state. The headline is itself misleading.


The fund for control of Japanese Encephalitis was released from NVBDCP, GOI, Delhi for combating Vector Borne Diseases to the State NVBDCP during the month of August, September/2014 & March/2015 a total Rs. 16.26 Crore through State Treasury. For combating JE the state has release fund to all the districts for DDT Spray operation, Fogging operation, ITBN camp along with IEC & in Monitoring & Supervision activities. Above all this all the districts are directed to use District Health Society interest fund for fogging & IEC activities if necessary.

Therefore shortage of fund to carryout preventive measures for combating Japanese Encephalitis is not acceptable.

Health & Family welfare department is always committed towards providing health care services to the people and combating of JE is of utmost priority.

This has the approval of the competent authority. Hence it is requested to publish the rejoinder.
