CORRIGENDUM NO.1

e-TENDER FOR ENTERING INTO RATE CONTRACT FOR SINGLE PUNCTURE LAPAROSCOPE AND ACCESSORIES

This has reference to the e-tender No: **NHM/PROC/Lapro/2270/2014-15/20561** Date: **30/10/2017** for entering into rate contract for "Supply of Single Puncture Laparoscope and Accessories". The following amendment may be taken note of prior to submission of Bids.

1. Sub-Clause B under Clause 3: ELIGIBILITY CRITERIA is amended to read as follows:

Average Annual turnover of the bidder (who is not a manufacturer) in the last three financial years 2014-15, 2015-16 and 2016-17 from the sales of **Laparoscope Machines** including Single Puncture Laparoscope Machines shall not be less than **Rs.240.00 Lakhs (Rupees Two Forty Lakhs only)**.

2. Sub-Clause J "Annual Turnover" under Clause 5: TECHNO-COMMERCIAL BID - COVER "A" is amended to read as follows:

Annual turnover statement from sales of **Single Puncture Laparoscope Machines** (*in case of Manufacturer participating as bidder*) and Annual turnover statement from sales of **Laparoscope Machines** including Single Puncture Laparoscope Machines (*in case of authorized dealer*) for last 3 years i.e. 2014-15, 2015-16 and 2016-17 in the format given in **Annexure-III A** (for authorized dealer) and **Annexure-III B** (for Manufacturer participating as bidder) certified by the Auditor/ Chartered Accountant. The certificate of Auditor/Chartered Accountant must be supported by attested copies of "Profit & Loss Statement" and "Balance sheet" of last three financial years. It is to be noted that such statement of both the bidder and the manufacturer (in case the bidder is not a manufacturer) must be submitted.

3. Sub-Clause B: "Earnest Money Deposit (EMD)" under Clause 5: TECHNO-COMMERCIAL BID - COVER "A" is amended to read as follows:

Earnest Money Deposit amounting to **Rs.12.00 Lakhs (Rupees Twelve Lakhs)** only in the form of **Demand Draft/Banker's Cheque/BG** favoring "State Health Society, Assam". Earnest Money Deposit will not earn any interest. The Earnest Money Deposit of the successful Bidder may, at the discretion of Tender Inviting Authority be adjusted towards the Security Deposit payable by the Bidder.

4. Bidder should have minimum 3 years of experience for supply and successful operation of Single Puncture Laparoscope machine in any of the last 7 financial years. This must be certified from user of at least three Govt. Health Institution/Medical Colleges. This shall form a part of the eligibility criteria.

All other terms and conditions of the tender referred to above shall remain unchanged. The start and end date of bid submission is extended to **27/11/2017** from 2:00 PM & **05/12/2017** up to 2:00 PM respectively. Bid shall be opened on **05/12/2017 at 4.00 PM**.
