Atal Amrit Abhiyan Society, Assam a Society notified by the Govt. of Assam and registered under the Societies Registration Act, 1860 for implementation of Atal Amrit Abhiyan Scheme, a unique Health Assurance Scheme in the State aimed to provide critical care health assurance coverage to BPL population and Low Income households. The Scheme covers selected procedures in six specialities viz. cardiovascular diseases, Cancer, Kidney diseases, Neonatal diseases, Neurological diseases and Burns with a total sum assured of Rs.2 Lakh per person per year for the treatment of approved procedures. The Scheme provides cashless medical treatment in the empanelled public and private hospitals, within and outside the State of Assam.

The Atal Amrit Abhiyan Society, Assam invites Expression of Interest (EOI) from Portals/Airlines/Travel Agencies for booking air tickets for patient and one attendant for treatment outside Assam:

Pre –Qualification Criteria:

1. The Agency should have IATA membership and should be serving at least one Govt. Organization for the last 3 financial years.
2. Agency should have experience of providing tickets to Govt. Organizations for past 3 financial years i.e. 2014-2015, 2015-16, 2016-17 and value of orders for one particular year from one particular Govt. Organization should be at least Rs.40.00 lakhs.
3. Average Annual Turnover of the bidder in the past three financial years i.e. 2014-2015, 2015-2016, 2016-2017 shall not be less than Rs.200.00 lakhs.
4. Bidder who has been black listed either by the Tender Inviting Authority or by any State Govt. or Central Government Organization will not be allowed to participate. In this regard, the bidder should submit from Public Notary or other Legal Competent Authority along with up-to-date self-attested Trade License, PAN CARD and GST Registration Certificate from Competent Authority.
5. The Bidder should also submit up-to-date self-attested copy of Trade License, PAN Card and GST Registration Certificate from the Competent Authority.
