**Eligibility Criteria:**

    - a. Registered APWD (Bldg)(Electrical) Class I-(A),I(B),I(C) & Class II / APDCL/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
    - b. The contractors having at least one similar nature of completed work value not less than 80% of the proposed cost during last 2 years.
    - c. The having PAN Card/VAT/ Registration/Labour License registration under EPF and MP Act,1952 etc are eligible are **ELIGIBLE** to participate in the bid process.
    - d. The contractor who was earlier allotted any NHM works by APWD (B), Assam or by NHM and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
    - e. The contractor & to whom extension of time was granted from NRHM imposing penalty will also not be **ELIGIBLE** to participate in the bidding process.
    - f. The intended bidders are asked to verify the site for the work prior to quoting their rates.
    - g. The intending bidders or their authorized representatives are to be present at the time of opening of Bids. Otherwise the bids will be opened in their absence and no claim will be entertained in future.
  2. Cost of tender document should be drawn in favour of State Health Society, Assam, payable at Guwahati in the form of **Pay Order/Demand Draft**.
  3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of CDR/ FDR/TDR and drawn in favour of the State Health Society, Assam, payable at Guwahati.
  4. Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned in Sl.1(a),(b),(c) to issue Bid Document: **26<sup>th</sup> July 2016** during working hours.
  5. Date for issuing of Bid Document: **27-07-2016 upto 17-00 Hrs.**
  6. Last date and time of submission of Bid: **29-07-2016 at 14-00 hrs.**
