SHORT NOTICE INVITING TENDER (SNIT)

The Office of the Mission Director, National Health Mission, Christian Basti, Guwahati-5 invites Bid in Single bid system (In F2 form) affixing court fee stamp of Rs.8.25 (Rupees Eight and Twenty Five Paise) only for the works under NHM as mentioned below:-

1. Eligibility Criteria:

- (a) Registered APWD (Bldg) Class I-A,B,C /Class-II/CPWD Contractors/Reputed Construction Company /Agency registered under Govt / Public sector undertaking.
 - (b) Contractors having at least one similar nature of completed work value not less than 80% of the proposed project cost during last 2(Two) years.
 - (c) The Contractor having PAN Card/VAT/Registration/Labour Licence/ registration under EPF and MP ACT,1952 etc are **ELIGIBLE** to participate in the bid process.
 - (d) The contractor who was earlier allotted any NHM works by APWD(B),ASHB or by NHM and could not complete the work in all respect in time/within the period up to which extension of time was granted without penalty will not be **ELIGIBLE** to participate in the bidding process.
 - (e) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed Building works under NHM on earlier occasion.
 - (f) The contractor and to whom extension of time was granted from NHM imposing penalty will also be not **ELIGIBLE** to participate in the bidding process.
 - (g) The intended bidders are asked to verify the site for the work prior to quoting their rates.
 - (h) **The intending bidders or their authorized representatives are to be present at the time of opening of Bids. Otherwise the bids will be opened in their absence and no claim will be entertained in future.**
2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at Guwahati in the form of **Pay Order/Demand Draft**.
 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of **TDR/FDR/CDR** and drawn in favour of the State Health Society, Assam, payable at Guwahati.
 4. **Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned at Sl.1 (a), (b) & (c) to issue Bid Document: 2nd August 2016 during working hours.**
 5. Date for issuing of Bid Document: **03-08-2016 up to 17- 00 hrs.**
 6. Last date and time of submission of Bid: **05-08-2016 at 14-00 hrs**
 - a. The bids will be opened at **15.30 hrs** of the same days as mentioned above.
 - b. In case, if any Bandh /Holiday falls in any sequence, the sequence will be held in the next working day.
