2. Clause No 15 – Supply Condition has been amendment as follows:.

SUPPLY CONDITIONS

a. Specifications and Quality

The items supplied by the successful bidder shall be of the best quality and shall comply with specifications, stipulations and conditions specified at **Annexure -V**

b. Delivery Period

The items should be delivered at NHM State Warehouse, Guwahati in two lots:

- i) **1st Lot: 75% of the total order quantity within 27th September 2016.**
- ii) **2nd lot: 25% of the remaining order quantity within 15th October 2016.**
- iii) **Sample copy of the item should be approved on 20th September 2016 and not later than 21st September 2016.**
- iv) Items delivered after the scheduled date of delivery shall not be accepted and termination of the contract may be considered. Non-compliance of the contract provisions shall make the successful bidder liable to be disqualified to participate in any tender for the next 5 years, in addition to forfeiture of Security Deposit/ EMD and other penal actions.

4. In the Annexure –II, ANNUAL TURNOVER STATEMENT OF THE BIDDER, the bidders will be allowed to provide Annual turnover statement of past three years either (i) 2012-13, 2013-14 & 2014-15 or (ii) 2013-14, 2014-15 and 2015-16.
5. The clause 10 (iii) Agreement has been amended as follows:

“The successful bidder shall execute an agreement on a non-judicial stamp paper of the value of Rs 100/- (stamp duty to be paid by the bidder) within 3 days from the date of the intimation from Tender Inviting Authority informing that his tender has been accepted or within 3 days from the date of issue of order”.
6. Clause 11 – Security Deposit has been amended as follows:

“The successful bidder, within 3 days of signing of the agreement, shall be required to submit Security Deposit of 5 % of the order value in the form of bank guarantee from any Indian nationalized bank in favour of “State Health Society, Assam” valid for a period of 6 months from the date of order. However, if the supplier fails to execute the order or fails to perform the services as per agreement, in addition to other penal actions, the bank guarantee shall be encashed and the amount will be forfeited.”
7. All other terms & conditions will remain same.
