**FOR HIRING A IMPLEMENTATION SUPPORT AGENCY FOR PROVIDING
SUPPORT SERVICES FOR IMPLEMENTATION OF THE**

“ATAL AMRIT ABHIYAN” OF THE GOVT. OF ASSAM”

(NATIONAL COMPETITIVE BIDDING)

1. The Government of Assam has taken a decision to launch a Health Assurance Scheme covering the State of Assam called “Atal Amrit Abhiyan” for providing cashless treatment and coverage of critical care targeted at the BPL population and Low Income households with annual income below Rs 5.00 Lakhs. The scheme will be implemented by the State Nodal Cell (SNC) setup for the purpose with the assistance of Implementation Support Agency (ISA) or Service Provider. The purpose of this e-tender notice is to select an ISA with whom SNC will sign a contract agreement for providing the services. More details may be seen in the detailed Request for Bid (RFB) document uploaded at <http://assamtenders.gov.in>.
2. The State Nodal Cell therefore is inviting e-Tenders under Two Envelop Bidding System (i.e. Technical & Financial Bid Separately) from the Companies (registered under the Companies Act) and associated with health care related activities, having experience in medical claim processing and providing IT support, for processing claims under the “Atal Amrit Abhiyan”. The complete Request for Bid (RFB) documents may be downloaded from the website-<http://assamtenders.gov.in>. The participating bidders should have valid Digital Signature Certificate (DSC) and have to register in the portal <http://assamtenders.gov.in>. The bid shall be submitted on-line in the portal <http://assamtenders.gov.in> on or before **2.00 PM of 26th October 2016**. Late bids shall not be accepted and summarily rejected.

3. The Bidder must upload scan copy of the document relating to payment of non-refundable Tender Fee of Rs.**2000**/- and Bid Security of **Rs.64,00,000**/- (Rupees Sixty Four Lakhs) only in the form of Demand Draft (DD)/Banker's Cheque (BC)/Bank Guarantee (BG) favoring "State Health Society, Assam", payable at Guwahati, along with the Technical bid submitted online. The Original DD for Tender Fee and the DD/BC/BG for Bid Security shall be submitted along with the hardcopy of Technical Bid to the State Nodal Cell-Atal Amrit Abhiyan, National Health Mission-Assam, Saikia Commercial Complex, Shrinagar Path, G S Road, Guwahati-781005, Assam on or before the last date and time of Submission of bids as mentioned above. The Technical Proposals shall be opened at **2.30 PM 26thOctober 2016**.
