- B. Cover "B" shall contain the Price Bid of the Tenderer.

A. **Signature & Seal on each Page**

Each page of the Price Bid should be duly signed by the Bidder affixing the office seal.

B. **Signature on corrections**

Bid should be typewritten and every correction in the bid should be attested with full signature by the Bidder, failing which the bid will be ineligible. Corrections done with correction fluid should also be duly attested.

C. **Landed Cost**

The "Price Bid" should contain the Cost of Transportation per Month and per Year including POL, Labour Charges for loading and unloading of drugs/surgicals /equipments (inclusive of all the taxes from district drug store, Kamrup Metro, AMSA House , Panbazar, Guwahati-1 to different peripheral health institutions within Kamrup Metro district.

**A. OPENING OF COVER “A” AND COVER “B” OF TENDER**

- B. All bidders are entitled to be present at the date and time of opening of Technical Bid - Cover “A”.
- C. Only those bidders whose Technical Bids are found to be acceptable after technical and commercial evaluation will be invited to be present at the date and time of opening of Price Bid - Cover “B” of the tender. The price bids of tenders not found technically qualified shall not be opened.

**1. VALIDITY OF BID:**

Bids shall remain valid for acceptance for a period of 90 days after opening of Technical Bid i.e. Cover ‘A’. Bids with shorter validity shall be rejected.

**2. VALIDITY OF OFFER OF SUCCESSFUL BIDDER:**

The validity of offer of the successful bidder shall be at least 01(one) year from the date of finalization of the work order and the successful bidder will be bound to execute the work order at agreed rates and terms during this period. This validity period may be further extended by one year with mutual consent and after successful completion of Service Contract.

**3. EVALUATION**

*Tenders will be evaluated with reference to technical and commercial parameters to determine the technically qualified bidders for all items.*

*Price Bids of technically qualified bidders will be evaluated with reference to the Basic rate as Transportation cost per Month including POL, Labour Charges for loading and unloading of drugs/surgicals /equipments (Excluding of all the taxes in Rs.) to determine the L-1 (Lowest) price.*

*Conditional discounts shall not be taken into account for price comparison.*

**4. Right to Reject Tender**

Tender Inviting Authority reserves the right to accept the tender or to reject the whole tender for the supply of all items or for any one or more of the items tendered at any point of time without assigning any reason.

**5. Tender Acceptance**

The acceptance of the tenders will be communicated to the successful bidders in writing.

**A. AGREEMENT**

The successful Bidder shall execute an agreement as per Annexure XVI on a non-judicial stamp paper of value of Rs 100/- (stamp duty to be paid by the Bidder) within 7 working days from the date of the intimation from Tender Inviting Authority informing that his tender has been accepted.

**B. NON ASSIGNMENT**

The Bidder shall not, at any time, assign, sub-let or make over the contract or the benefit thereof or any part thereof to any person or persons, whatsoever.

**C. COMMUNICATION**

All notices or communications relating to or arising out of an agreement or any of the terms thereof shall be considered duly served on or given to the Bidder if delivered to him or left at his premises, places of business or abode.

**E. SECURITY DEPOSIT**

The successful bidder, within 7 working days of signing of the agreement, shall be required to submit Security Deposit of 5 % of the contract value in the form of bank guarantee from any Indian scheduled bank in favour of the Tender Inviting Authority valid for a period of 1 year from the date of order. However, if the supplier fails to execute the order or fails to perform the services as per agreement, in addition to other penal actions, the bank guarantee shall be encased and the amount will be forfeited. The security deposit shall need to be renewed by another one year in case of re-order for the next one year after mutual consent.

**F. Penalty for Delayed in Service Delivery**

- (i) In case there is delay in providing vehicle beyond the stipulated period, 2% may be deducted from the Monthly Bill.
- (ii) Once the maximum price reduction is reached, termination of the contract may be considered. Non-performance of the contract provisions shall make the successful bidder liable to be disqualified to participate in any tender for the next 3 years, in addition to forfeiture of Security Deposit and other penal actions.

**G. Shortage and Damage**

It shall be the responsibility of the successful Bidder for any shortages/damages at the time of transportation and receipt in peripheral hospitals from District Drug Store, Kamrup (Metro).

**H. FORCE MAJUERE**

The above conditions of delivery period, price reduction & termination etc. are subject to force majeure conditions which are beyond the control of the supplier, do not involve fault or negligence of the supplier and are not anticipated. Such events may include but are not limited to riots, mutinies, war, fire, storm, tempest, flood, earthquakes, epidemics, or other exceptional causes like quarantine restrictions, freight embargoes.

**M. LOCAL CONDITIONS:**

It will be imperative on each bidder to fully acquaint himself of all local conditions and factors that would have any effect on performance of the Contract. The Tender Inviting Authority shall not entertain any request for clarifications from the bidder regarding such local conditions nor shall accept any offer conditional to the local factors. No request for any change of price after acceptance of bids.

**J. PAYMENT PROVISIONS**

- A. Payments will be made strictly as per rules of the Tender Inviting Authority. All payments shall be made by way of Crossed A/C Payee Cheque drawn in favour of the bidder.
- B. On completion of monthly work of transportations of Drugs/Surgicals/Equipments, the monthly bills/ Invoices submission should be accompanied with copies of Log-sheet cum Rod Challan duly sealed and signed by Jt.DHS, Kamrup Metro and DDSM Kamrup Metro and receipt acknowledgement by concerned hospital authority or representative.
- C. Monthly payment will be made in a single installment on completion of transportation of drugs/surgicals/equipments from District Drug Store, Kamrup, Metro to different peripheral hospitals under Kamrup Metro District.
